Jumper Nomination	\$125	Assessed all horses in Welcome, 1.25M Jumper Prix, 1.25M Div, A/O Jr Jpr Div
Schooling Fee	\$40	Assessed all horses except Grand Prix horses; dedicated schooling ring available with full course throughout circuit.
USEF Show Pass Fee	\$45	Applies to Show Pass Riders, Trainers, Owners, Coaches and Agents
USHJA Show Pass Fee	\$30	Applies to Show Pass Riders, Trainers, Owners, Coaches and Agents
USEF/USHJA Drugs and Medications	\$25	Applies to all showing horses (USEF \$15 + \$8, USHJA \$2)
Horse Trailer-In Fee	\$100	Per day, assessed if not stabled at show grounds. MUST CALL IN ADVANCE 941-809-6361
Paddock Rental	\$250	Per Week, Paddocks assigned by management. Paddocks may be split by management between farms.
